



## **FINANCIAL REGULATIONS OF THE LYCEE FRANCAIS** **INTERNATIONAL DE DELHI** **ACADEMIC YEAR 2026-2027**

### **REFUNDABLE DEPOSIT**

**A deposit of 500 € per student is to be paid with the registration fees.**

This deposit is automatically refunded to the family or company financing the student's education within three months of the student's departure from the LFID.

Deductions will be made in the event of unpaid tuition fees, unpaid bills or unreturned books. Bills may include: school trips, damage to school property, Cambridge exam fees etc.

### **REGISTRATION FEES**

Registration fees are payable at the time of initial registration at the LFID. A student is deemed to be registered only after the actual payment of these registration fees.

**The fees will not be refunded under any circumstances.**

**Amount:** Students of French or Indian nationality or Overseas citizen of India (OCI): **3 960 €**  
Students of other nationalities: **5 280 €**

### **ANNUAL TUITION FEES 2026-2027**

Fees for every term begun are payable in full, except for Playschool (prorated at 10% per month). In case of any interruption of schooling during the term, the tuition fees for the term will not be refunded.

### School Insurance: 42 € / year

For Middle school students and senior school students of class Seconde enrolled in the **British International Section** and students of Première and Terminale enrolled in the **International French Baccalaureate**: **1185 € additional annual charges**

In the LFID, secondary school students study English as Modern Language A (LVA) and German or Spanish as Modern Language B (LVB). However, some students who have studied other languages before coming to LFID, may, on the advice of the Head of School, choose to study another modern language in option LVA or LVB via the **National Centre for Distance Education (CNED)**. In this case, the tuition fees payable to the CNED are paid by the LFID.

If a student chooses to study an additional foreign language via CNED, in option LVC which is non-compulsory in the French curriculum, the tuition fees due to CNED are paid by the student's family.

### Discounts / Rebates on tuition fees:

Large families: 25% reduction for the 4th child, 50% reduction for the 5th and more if all children are enrolled in the LFID.

## DATES FOR PAYMENT

The payment of tuition fees for Nursery, Primary and Secondary school classes is spread out as follows:

30/09/26 for the first term: <sup>1*</sup>	40 %
30/11/26 for the second term: <sup>2*</sup>	35 %
28/02/27 for the third term:*	25 %

\*The term-wise payment schedule corresponds to the following periods:

- Term 1: from 1st September (or beginning of the academic year) to 31<sup>st</sup> December
- Term 2: From 1<sup>st</sup> January to 30<sup>th</sup> April
- Term 3: From 1<sup>st</sup> May to 30<sup>th</sup> June (or end of the academic year)

Exceptionally, monthly payments are possible. For this, a specific request should be sent directly to the treasurer of the Parents Association. The monthly installment for the academic year would then be agreed between the counterparts.

### Re-enrolment

An advance of 10% of the tuition fee for 2026-2027 is to be paid before 17/05/2026 to guarantee the availability of a seat.

In case of failure to pay this advance, the LFID cannot guarantee a seat to the student for the next session.

## MODE OF PAYMENT FOR REGISTRATION AND TUITION FEES

The payment of fees should be in Euros or Indian Rupees in respective banking accounts. Fees may also be paid in USD with a fixed rate commission of 7% for foreign exchange rate risk.

For payment in Indian Rupees, the chancery exchange rate (1) on the date the invoice was issued will be applied.

(1) *The chancery exchange rate is the exchange rate fixed under the direction of the Ministry of Economy, Finance and Industry in France.*

**Cash payments are not accepted.**

Payments are to be made:

- By French cheques or bank transfer in euros in favour of "Ecole française de Delhi". All the bank fees are at the charge of the emitter, by selecting the option "OUR".
- By cheque in Indian Rupees in favour of "**LYCEE FRANCAIS INTERNATIONAL DE DELHI**".

Any expenses incurred by the LFID due to:

- the absence of the IBAN or BIC/ Swift code specifications during the bank transfer
- bank charges of the issuer bank

are to be paid by the families-embassy/company-international organization in question. The heading 'Tuition Fees' and the family last name must both be mentioned on the bank transfer.

No new student will be allowed to begin class until registration fees are paid.

## SCHOLARSHIP BY THE FRENCH GOVERNMENT

All information may be obtained from the consular section of the French Embassy.

Students of French nationality may avail of academic scholarships subject to their application being accepted.

The completed applications for a first time demand for a scholarship or a renewal of scholarship are to be submitted to the *chargé d'affaires sociales* (social affairs in charge) of the consular section within the prescribed time limit.

## PAYMENT DEFAULTS

Any delay in payment exceeding 30 days will result in levy of a penalty at the rate of 2% for every month of delay.

Should any family anticipate difficulties in paying their child(ren)'s tuition fees or other school expenses in time, it is their responsibility to obtain, at least 24h prior to the published payment deadline, a Late Payment Plan (LPP) from LFID's Managing Committee (including possible late payment penalties). If no prior approval has been obtained, any child whose dues remain unpaid by the payment deadline will be allowed to attend school only until the start of the following school holidays. The child will then be suspended until all pending dues and penalties have been cleared, or until a LPP has been approved by the Management Committee.



Please note that the approval of an LPP by LFID's Management Committee can take up to 20 working days from the date of receiving a formal written request.

Failure to meet the payment terms of an approved LPP will result in the immediate suspension of the child whose expenses remain unpaid, starting from the day after the first missed deadline. LFID and the Managing Committee will not be responsible for any consequences arising from a child's absence due to their parents' failure to pay school expenses (tuition fees or other charges) on time.

A school leaving certificate will not be issued to any child whose family has outstanding dues with LFID.

### **REFUNDABLE DEPOSIT**

### School Insurance: 42 € / year

For Middle school students and senior school students of class Seconde enrolled in the **British International Section** and students of Première and Terminale enrolled in the **International French Baccalaureate**: **1185 € additional annual charges**

In the LFID, secondary school students study English as Modern Language A (LVA) and German or Spanish as Modern Language B (LVB). However, some students who have studied other languages before coming to LFID, may, on the advice of the Head of School, choose to study another modern language in option LVA or LVB via the **National Centre for Distance Education (CNED)**. ### DATES FOR PAYMENT

The payment of tuition fees for Nursery, Primary and Secondary school classes is spread out as follows:

30/11/25 for the second term: <sup>2*</sup>	35 %
28/02/26 for the third term:*	25 %

\*The term-wise payment schedule corresponds to the following periods:

- Term 1: from 1st September (or beginning of the academic year) to 31<sup>st</sup> December
- Term 2: From 1<sup>st</sup> January to 30<sup>th</sup> April
- Term 3: From 1<sup>st</sup> May to 30<sup>th</sup> June (or end of the academic year)

Exceptionally, monthly payments are possible. For this, a specific request should be sent directly to the treasurer of the Parents Association. The monthly installment for the academic year would then be agreed between the counterparts.

### Re-enrolment

An advance of 10% of the tuition fee for 2025-2026 is to be paid before 17/05/2025 to guarantee the availability of a seat.
